The Mayor, Councillor Wise and Councillor Best all declared personal non prejudicial interests in Item 8 as members of the Sydenham Society.

Councillor Best also declared a prejudicial interest in Item 8 as a resident of the Thorpes Conservation Area. In accordance with the Code of Conduct adopted by the Council at its July meeting, she made a representation on this item as a ward member and then withdrew from the meeting for the remainder of the debate and the decision.

8 Conservation Area Review: Sydenham Town Centre (page

The Director of Regeneration's representative presented the report and tabled an addendum to the report proposing an expansion to the Sydenham Thorpes conservation area as shown as areas in green and outlined in red on a modified plan. This proposal was accepted by the Mayor.

The Mayor received representations from Pat Trembath, Chair of the Sydenham Society and Annabel McLaren, Chair of the Sydenham Society's Conservation and Planning Sub Committee who called for the creation of a Cobbs Corner and Central Sydenham Conservation Area. They referred to a letter of support from Architectural historian Professor Gavin Stamp and outlined in detail the architectural significance of properties in Kirkdale, Spring Hill, Peak Hill Gardens, Peak Hill Avenue, Kinver Road and Peak Hill.

The Cabinet Member for Community Services spoke in support of the Sydenham Society's proposals and then withdrew from the meeting.

Councillor Hall praised the work of his colleague Councillor

Ibitson in campaigning generally for the preservation of public houses in Lewisham and he referred to the motion passed at Council on this subject. He urged officers to consider formulating policies for inclusion in the Lewisham Development Framework which afforded greater protection to public houses.

The Director of Regeneration's representative advised the Mayor on the local listing process and that this would not necessarily prevent demolition of a building. He further advised consultation on the LDF and its draft policies was a separate process and that the Mayor should focus on the merits of proposals to extend the Thorps Conservation Area and the possible creation of a new separate Cobbs Corner and Central Sydenham Conservation Area west of the railway.

In response, the Mayor congratulated officers on a particularly interesting and well informed presentation. He accepted all the recommendations they had proposed and he further stated he was prepared to accept the case for a new Cobbs Corner Conservation Area having being convinced there were a number of buildings in the locality that taken together added up to a strong justification for conservation area status.

She stated a robust response was required which would correct the numerous inaccuracies she felt were contained within the report.

- (iv) to delegate authority to the Executive Director for Resources, in consultation with the Executive Director for Regeneration, Acting Head of Property and Development and the Head of Law, to negotiate the proposed terms of the Development Agreement and all associated legal agreements with Network Rail; and
- (v) to note that the proposed terms of the Development Agreement and all associated legal agreements will be the subject of a separate report to Mayor and Cabinet for approval.
