1 Personal interests

There are three types of personal interest referred to in the Council's Member Code of Conduct :-

- (1) Disclosable pecuniary interests
- (2) Other registerable interests
- (3) Non-registerable interests
- 2 Disclosable pecuniary interests are defined by regulation as:-
- (a) <u>Employment,</u> trade, profession or vocation of a relevant person* for profit or gain
- (b) <u>Sponsorship</u> –payment or provision of any other financial benefit (other than by the Council) within the 12 months prior to giving notice for inclusion in the register in respect of expenses incurred by you in carrying out duties as a member or towards your election expenses (including payment or financial benefit from a Trade Union).
- (c) <u>Undischarged contracts</u> between a relevant person* (or a firm in which they are a partner or a body corporate in which they are a director, or in the securities of which they have a beneficial interest) and the Council for goods, services or works.
- (d) Beneficial interests in land in the borough.
- (e) <u>Licence to occupy land</u> in the borough for one month or more.
- (f) <u>Corporate tenancies</u> any tenancy, where to the member's knowledge, the Council is landlord and the tenant is a firm in which the relevant person* is a

partner, a body corporate in which they are a director, or in the securities of which they have a beneficial interest.

(g) <u>Beneficial interest in securities</u> of a body where:-

- (a) that body to the member's knowledge has a place of business or land in the borough; and
- (b) either
 - (i) the total nominal value of the securities exceeds £25,000 or 1/100 of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person* has a beneficial interest exceeds 1/100 of the total issued share capital of that class.

(3) Other registerable interests

The Lewisham Member Code of Conduct requires members also to register the following interests:-

- (a) Membership or position of control or management in a body to which you were appointed or nominated by the Council
- (b) Any body exercising functions of a public nature or directed to charitable purposes, or whose principal purposes include the influence of public opinion or policy, including any political party
- (c) Any person from whom you have received a gift or hospitality with an estimated value of at least £25

(4) Non registerable interests

Occasions may arise when a matter under consideration would or would be likely to affect the wellbeing of a member, their family, friend or close associate more than it would affect the wellbeing of those in the local area generally, but which is not required to be registered in the Register of Members' Interests (for example a matter concerning the closure of a school at which a Member's child attends).

(5) Declaration and Impact of interest on members' participation

(a) Where a member has any registerable interest in a matter and they are present at a meeting at which that matter is to be discussed, they must declare the nature of the interest at the earliest opportunity and in any

^{*}A relevant person is the member, their spouse or civil partner, or a person with whom they live as spouse or civil partner.

event before the matter is considered. The declaration will be recorded in the minutes of the meeting. If the matter is a disclosable pecuniary interest the member must take not part in consideration of the matter and withdraw from the room before it is considered. They must not seek improperly to influence the decision in any way. Failure to declare such an interest which has not already been entered in the Register of Members' Interests, or participation where such an interest exists, is liable to prosecution and on conviction carries a fine of up to £5000

- (b) Where a member has a registerable interest which falls short of a disclosable pecuniary interest they must still declare the nature of the interest to the meeting at the earliest opportunity and in any event before the matter is considered, but they may stay in the room, participate in consideration of the matter and vote on it unless paragraph (c) below applies.
- (c) Where a member has a registerable interest which falls short of a disclosable pecuniary interest, the member must consider whether a reasonable member of the public in possession of the facts would think that their interest is so significant that it would be likely to impair the member's judgement of the public interest. If so, the member must withdraw and take no part in consideration of the matter nor seek to influence the outcome improperly.
- (d) If a non-registerable interest arises which affects the wellbeing of a member, their, family, friend or close associate more than it would affect those in the local area generally, then the provisions relating to the declarations of interest and withdrawal apply as if it were a registerable interest.
- (e) Decisions relating to declarations of interests are for the member's personal judgement, though in cases of doubt they may wish to seek the advice of the Monitoring Officer.

(6) Sensitive information

There are special provisions relating to sensitive interests. These are interests the disclosure of which would be likely to expose the member to risk of violence or intimidation where the Monitoring Officer has agreed that such interest need not be registered. Members with such an interest are referred to the Code and advised to seek advice from the Monitoring Officer in advance.

(7) Exempt categories

There are exemptions to these provisions allowing members to participate in decisions notwithstanding interests that would otherwise prevent them doing so. These include:-

- (a) Housing holding a tenancy or lease with the Council unless the matter relates to your particular tenancy or lease; (subject to arrears exception)
- (b) School meals, school transport and travelling expenses; if you are a parent or guardian of a child in full time education, or a school governor unless the matter relates particularly to the school your child attends or of which you are a governor;
- (c) Statutory sick pay; if you are in receipt
- (d) Allowances, payment or indemnity for members
- (e) Ceremonial honours for members
- (f) Setting Council Tax or precept (subject to arrears exception)

<u>Proposal</u>: Premises Licence Variation

<u>Legislation</u>: Licensing Act 2003

Premises: Oregano Leaf 98 New Cross Road SE14 5BA

Applicants: Allahdad Momtaz 353 Brownhill Road SE6 1AL

This is an application for a full variation to be considered pursuant to section 35 of the Licensing Act 2003

1. Background

An application for a full variation was received on 13 February 2018 in relation to extending the provision of late night refreshments. 2300 until 0300 on Thursday to Sunday and 2300 until 0500 Friday and Saturday.

2. Outline Grounds for Objection

- 2.1 An application for the full variation of the premises licence was sent to all the Responsible Authorities. Representations were received from the Metropolitan Police and the Crime Enforcement and Regulation service in relation to the licensing objectives of the prevention of Crime and Disorder and of Public Nuisance. Representations were also received from three members of the public.
- 2.2 The application for the variation has been advertised in accordance with regulation 39, displayed prominently a notice at the premises, and at the Council's main offices for a period of 28 consecutive days. The last date for receiving representations was the 14th March 2018.

3. <u>Current Licence Status</u>

The premises are currently licensed – See attached licence

4. <u>Legal & Human Rights Implications</u>

- 4.1 An interested party or responsible authority can apply to the licensing authority for a full variation of a Premises Licence. The Licensing authority is required to hold a hearing to consider the application for a full variation and any relevant representations made. The representations are required to be relevant to one or more of the licensing objectives.
- 4.2 The Licensing authority is a public authority under the Human Rights Act 1998. Therefore the licensing authority is required to act compatibly with the convention rights in the exercise of their functions. Article 6 (1) of the Convention provides that everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial hearing established by law.
- 4.3 A Premises Licence is a possession for the purpose of the Human Rights Act 1998. The right to hold a licence is a qualified rather than an absolute right. Therefore the right to hold a licence may be interfered with if it affects the interests of local residents or others. Such interference may be justified if it is necessary and proportionate to promote the licensing objectives.

5. Application for Full variation

5.1 After having regard to all representations, Members must take such steps as they consider necessary for the promotion of the licensing objectives. The Licensing Committee may;

(a) modify the conditions of the licence; OR

(b) reject the whole or part of the application;

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

5.2 An appeal may be made against the decision to the Magistrates Court by the applicant for the variation and any persons who made a valid representation.

Dear Licensing Department

On behalf of the MPS I hereby give notice of my objection to the application for a Full Variation for the Oregano Leaf at 98 New Cross Road SE14.

I make representations for this Full variation under the prevention of crime and disorder objective.

As part of the application process I attended Oregano Leaf on the 6th March 2018 with officers form the council. Oregano leaf only has one condition and that relates to the premises having CCTV and it must record for 31days. Also in the condition it states that one member of staff on duty at the premises must be capable of operating it at all times. When we conducted the visit there was two members of staff present a Mr Khalid ANWAR and Mr Momtaz KNOAJMIR, neither member of staff could advise me how long the CCTV recorded for and they could not operate it. The premises License was displayed but was not displayed properly, for example to be displayed properly all three parts of the license need to be displayed separately but on this visit they were not.

I appreciate these two breaches may appear to be minor but they only have one condition on their license and they have still beached this. When I visited previously on the 12th July 2017 I found the same 2 breaches.

Applying for a late license in a CIZ comes with a large responsibility. I appreciate that they would now appear to be operating within their current licensable hours which is a good step forward but I am disappointed they still have not addressed the license breaches. I also feel that if they can't address the CCTV issue and the displaying the license I have concerns they will not protect the License objectives. I also feel that CCTV is a vital part of not only protecting them self's and their customers but also the crime and disorder objective.

I have noted the Representation provided by Lisa Spall and I completely agree that at this stage I would want to see a reduction of hours for this application and the addition of further conditions to the license to help protect the licensing objectives.

This would enable the premises to prove to us that they can operate in such a way that would give me confidence that if they were to apply again to extend their hours I would be happy to not object.

The new hours for this application I request are:

Sunday to Thursday open until 01:00hrs Friday and Saturday open until 02:00hrs

The additional Conditions I would request are:

An incident log shall be kept at the premises, and made available on request to an authorized officer of the Council or the Police, which will record the following:

- (a) All crimes reported to the venue
- (b) All ejections of patrons
- (c) Any complaints received
- (d) Any incidents of disorder
- (e) Any faults in the CCTV system
- (f) Any visit by a relevant authority or emergency service.

The premises license holder shall ensure all persons who work on the premises have provided satisfactory proof of identification and the right to work and have carried out checks on the home office website to verify identification, visa and the right to work documents.

All documents of members of staff will be retained for a period of 12 months post termination of employment and will be made available to the police, immigration and/or Licensing officers upon reasonable request.

I am aware that the CER service at Lewisham council have already approached the representative's solicitors with this amendment and it has been rejected. If the applicant wishes to re consider and accept these amendments I would be happy to withdraw my representation.

Full Variation - Extension of licensable hours (Late Night Refreshment) - Oregano Leaf, 98 New Cross Road, SE14 5BA

Please be aware that on behalf of The Crime, Enforcement and Regulation Service I provide notice of my objection to the proposed full variation of the above stated premises.

Additionally, it has been necessary to object to the full variation enabling the extension of licensable activity in the form of late night refreshment as a consequence of Oregano Leaf, 98 New Cross Road, SE14 5BA in the opinion of the licensing authority failing to safeguard key licensing objectives most notably the prevention of crime and disorder and the prevention of public nuisance.

In response to a complaint received by the aforementioned service on Sunday 21st May 2017 in relation to noise nuisance as a consequence of motorcycle deliveries taking place until as late as 05:00am, the following measures were undertaken to ensure compliance with the existing premises licence;

- Monday 22nd May 2017 CER Officers visited the licensed premises and discussed concerns in relation to alleged trading outside of authorised licensable hours in addition to noise nuisance as a consequence of motor vehicle deliveries until 04:00am Monday - Thursday and 06:00am Friday - Sunday.
- Tuesday 23rd May 2017 CER Officers provided pre application advice to the above licensed premises as a means of informing the premise of the possibility of extending licensable hours via the use of Temporary Event Notices and/or a premises licence, officers reiterated that further incidents of trading past permitted hours would result in action via s136 of the Licensing Act 2003.
- Tuesday 6th June 2017 CER Officers visited the premises at approximately 00:20am, twenty minutes after permitted hours and observed the continued provision of late night refreshment.
- Tuesday 27th June 2017 The Licensing Authority received notification of a full variation application on behalf of Oregano Leaf, 98 New Cross Road, SE14 5BA
- Sunday 2nd July 2017 CER Officers visited the premises at approximately 01:50am and observed the continued provision of licensable activity past 00:00am.

 Monday 3rd July 2017 – The Premises Licence Holder met with CER Officers as a means of discussing offences observed in relation to s136 of the Licensing Act 2003.

Furthermore, subsequent data protection requests via two separate delivery platforms, JustEat and Hungry House, confirmed persistent licensable activity after permitted hours, since The Crime, Enforcement and Regulation Service have attempted to ensure compliance. The details of offences were considered at the previous hearing to discuss a full variation.

Additionally, the Crime, Enforcement and Regulation Service also undertook a visit to the premises on Wednesday 12th July 2017 in partnership with Immigration Enforcement and the Metropolitan Police Service, during the visit a gentleman identified as the Chef was arrested for immigration offences.

With the above in mind The Crime, Enforcement and Regulation Service have taken note of Part 11.27 of the Home Office Revised Guidance under S182 of The Licensing Act 2003 in supporting any subsequent review of the premises licence as a consequence the above mentioned criminal activity.

This was considered at a previous hearing to in relation to a full variation application held on Tuesday 15th August 2017. As a consequence, the application to extend the hours of licensable activity was objected to.

Actions since Previous Full Variation Application

As a consequence of the refused variation I met with the licensee Mr Zardad Momtaz on Tuesday 5th September 2017 where I mentioned ongoing concerns in relation to compliance with the existing premises licence.

Furthermore, Mr Momtaz was informed that the continued failure since the variation hearing to satisfy Annex 2, Condition 1 in relation to the use of CCTV as well as the failure to satisfy s57 of The Licensing Act 2003 in relation to the displaying of a summary licence required immediate action to avoid the likelihood of further enforcement action. The gentleman adhered to the requests which were observed by Nadya Gencheva and I on a visit to the premise on Friday 8th September 2017.

I have since acknowledged the transfer of the premises licence from Mr Zardad Momtaz to his brother Mr Allahdad Momtaz. In addition Mr Allahdad Momtaz was invited to meet with PC Nick Gerry, Lisa Spall and I on Tuesday 7th November 2017 before submitting the relevant transfer application as a means of confirming expectations to abate the likelihood of further breaches in relation to the existing premises licence.

Mr Allahdad Momtaz enquired on more than one occasion with regard to an extension of hours in relation to licensable activity, nevertheless, officers stated that at this stage an application was premature and suggested that the proposed licensee demonstrate a commitment to adhere to the current obligations of the premises licence before applying for a variation seeking the increase of hours. Moreover, officers suggested revisiting the matter in six months from the date of the transfer of licensee being approved.

Since this a data protection request was made to JustEat assessing sales after permitted hours, nonetheless, I was informed by JustEat that a block on sales has been imposed after midnight by the delivery platform in response to previous concerns raised by the local authority.

Additionally, a follow up visit was undertaken on Tuesday 6th March 2018 where officers noted compliance in relation to hours of permitted licensable activity. Nonetheless, a follow

up visit was proposed for Monday 12th March 2018 where officers observed compliance of Annex 2 conditions in relation to the operation and subsequent handling of CCTV footage.

The addition of the following conditions as well as the following amendment of proposed licensable activity would in the opinion of the Crime, Enforcement and Regulation Service adequately safeguard key licensing objectives of paramount importance taking into account that the premises is located within an existing Cumulative Impact Zone.

- Sunday to Thursday 00:00 until 01:00am
- Friday & Saturday 00:00 until 02:00am

The proposed conditions are as follows;

An incident log shall be kept at the premises, and made available on request to an authorised officer of the Council or the Police, which will record the following:

- (a) All crimes reported to the venue
- (b) All ejections of customers
- (c) Any complaints received
- (d) Any incidents of disorder
- (e) Any faults in the CCTV system or searching equipment or scanning equipment
- (f) Any visit by a relevant authority or emergency service.

The premises licence holder shall ensure all persons who work on the premises have provided satisfactory proof of identification and the right to work and have carried out checks on the home office website to verify identification, visa and the right to work documents.

All documents of members of staff will be retained for a period of 12 months post termination of employment and will be made available to the police, immigration and/or Licensing officers upon reasonable request.

As soon as possible, and in any event within 1 month from the grant of this license, the premises shall join The Safer London Business Partnership approved by the police, and local radio scheme if available.

Should the applicant consider the above appropriate, The Crime, Enforcement and Regulation Service would withdraw the representation. Nonetheless, to date I understand that the applicant has suggested that he does not wish to discuss the proposed amendment.

It was very distressing to see from our window 15 hooded youths with clubs fighting the Oregano Leaf staff that were using long poles and gardening tools in what looked like to defend themselves. It wasn't until someone from the pizza shop ran out with a very big knife that the youths all ran off.

I wish to object to the variation in the licence.

While I note that there has been a change following the first request, the new request remains unacceptable.

In considering the revised request I have consulted with the Kender Tenants and Residents Association. The Association engages and represents residents living on the Lewisham Homes estate which is situated a little further west along New Cross Road. nearby. The matter was discussed at their tenants' meeting last night.

Kender TRA and myself remain concerned about the impact of the requested opening house on residents living nearby, and in particular those in Gerrard House and on Briant Street which is less than 1 minute walk from the take away. Our concerns relate to late night opening leading to:

- An increase in noise within the premises, on its forecourt and in the street during the sleeping hours, caused by the cars and motorbikes of delivery drivers and visitors to the take away, who inevitably park in Briant Street (New Cross Road is on a Red Route).
- An increase in late night footfall leading to an increase in anti-social behaviour on the street and in nearby estate and residential streets.

As such we believe the license should be refused in order to:

- Prevent a public nuisance.

1. Background

An application for a full variation was received on 13 February 2018 in relation to extending the provision of late night refreshments. 2300 until 0200 on Thursday to Sunday and 2300 until 0300 Friday and Saturday.

2. Outline Grounds for Objection

- 2.1 An application for the full variation of the premises licence was sent to all the Responsible Authorities. Representations were received from the Metropolitan Police, Planning Service and the Crime Enforcement and Regulation service in relation to the licensing objectives of the prevention of Crime and Disorder and of Public Nuisance. Representations were also received from three members of the public living in the immediate vicinity.
- 2.2 The application for the variation has been advertised in accordance with regulation 39, displayed prominently a notice at the premises, and at the Council's main offices for a period of 28 consecutive days. The last date for receiving representations was the 14th March 2018.

3. Current Licence Status

The premises are currently licensed – See attached licence Page 43

4. <u>Legal & Human Rights Implications</u>

- 4.1 An interested party or responsible authority can apply to the licensing authority for a full variation of a Premises Licence. The Licensing authority is required to hold a hearing to consider the application for a full variation and any relevant representations made. The representations are required to be relevant to one or more of the licensing objectives.
- 4.2 The Licensing authority is a public authority under the Human Rights Act 1998. Therefore the licensing authority is required to act compatibly with the convention rights in the exercise of their functions. Article 6 (1) of the Convention provides that everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial hearing established by law.
- 4.3 A Premises Licence is a possession for the purpose of the Human Rights Act 1998. The right to hold a licence is a qualified rather than an absolute right. Therefore the right to hold a licence may be interfered with if it affects the interests of local residents or others. Such interference may be justified if it is necessary and proportionate to promote the licensing objectives.

5. Application for Full variation

- 5.1 After having regard to all representations, Members must take such steps as they consider necessary for the promotion of the licensing objectives. The Licensing Committee may:
 - (a) modify the conditions of the licence; OR
 - (b) reject the whole or part of the application;

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

5.2 An appeal may be made against the decision to the Magistrates Court by the applicant for the variation and any persons who made a valid representation.



On behalf of the MPS I hereby give notice of my representations against the granting of the Full variation for Top Hut Pizza and Chicken at 403 Hither Green Lane, SE13 6TR. I make my representation under the crime and disorder objective.

I have been made aware by Lewisham council licensing that they have received information from Just Eat that Top Hut Pizza and Chicken have been trading past their current hours. At this stage I have only been provided with 4 days of orders and on three of the day's Top Hut Pizza have traded past there hours. The dates and times are as follows.

3rd March 2018, 7 orders after their closing time of 01:30hrs and the last order was at 02:11hrs.

4th March 2018, 19 orders after their closing time of 00:00hrs and the last order was at 02:26hrs.

5th March 2018, No orders after hours.

6th March 2018, 2 orders after their closing time of 00:00hrs and the last order was at 00:56hrs.

I find this unacceptable. The premises licence holder Mr Abdul Ajan Haidari would have been aware of his opening hours as he has applied for this variation to extend his hours.

I also attended Top Hut Pizza and chicken with Kelly Hickmott from the CER team at Lewisham council on the 5th March 2018 and met Mr Haidari where we discussed his new application and his trading hours .I have noted that the 5th March we have had no orders past his trading hours but we had 2 orders past his license hours on the very next day. It have also visited the web site of Top Hut Pizza today and they are advertising that they are open until 01:30hrs. They should only be open until Midnight.

This is a complete disregard for the Licensing objectives and fear that if this application is granted this will put the licensing objectives at further risk.

I respectfully request that this representation against the full Variation for Top Hut Pizza and Chicken be accepted.

Please be aware that on behalf of The Crime, Enforcement and Regulation Service I provide notice of my objection to the proposed full variation of the above stated premises.

Additionally, it has been necessary to object to the full variation enabling the extension of licensable activity in the form of late night refreshment as a consequence of Top Hut Pizza & Chicken, 403 Hither Green Lane SE13 6TR in the opinion of the licensing authority failing to safeguard key licensing objectives most notably the prevention of crime and disorder and the prevention of public nuisance.

- On the 11th January 2018 CER officers visited the address as a result of a complaint received about the premises not having a food registration and also advertising times on their website that was outside of their licensable hours. Advice was given in terms of their times being advertised and their licence on display.
- On the 14th February the licensing authority received an application for a full variation to extend the times of their licence.
- On the 5th March 2018 a data protection request form was submitted by Manager Lisa Spall to one of the several delivery platforms JUST EAT as exhibited KH1. They confirmed that persistent licensable activity after permitted hours between 03/03/2018 to 06/03/2018 this is highlighted in KH2

Therefore, details as provided above confirm that the licensed premise has persistently failed to uphold key licensable activity, the above provided information confirms 28 offences within a 4 day period all of which amount to an offence via section 136 of the licensing act in relation to an unauthorised licensable activity. I object to the application for a variation of premises license at 403 Hither Green Lane.

My property is located Brownhill Road. This is a terrace property within a dense family residential area it has a rear garden that backs on to the gardens of the opposite terrace and I have a view of the applicant's property

I object for the reasons below.

- The business activities already require multiple mopeds starting up and driving around as well as customers driving to and from the location, this will increase the length of time these activities operate into unsociable hours.
- The premises already attracts considerable walk in customers some of whom are within the current opening hours unruly and loud, this will only increase the number of noise nuisance incidents.
- The location of the proposal is directly opposite the terrace gardens and this prolonged noise activity would seriously impact me at night when the noise will be amplified though this quiet garden space.
- Whilst I live on a busy main road traffic volumes significantly reduce around midnight. During the summer having rear bedroom windows open is desirable and this benefit may be compromised by the starting of engines and intoxicated patrons behaving loudly on the pavement outside.
- No other shops units on this parade, or indeed within the immediate vicinity operate at such late hours.

I also think these is a large difference between passing traffic and people or vehicles hanging around for indefinite periods and that this type of activity Is likely to increase with extended hours.

Further more I have already complained to the council (Ref EN/17/00606) about the applicant's previous failure to obtain planning consent for recent shop front alterations part of which was an internally illuminated shop sign.

This sign is overly large and extremely bright. It is causing a light nuisance into the rear rooms of my property and garden. The extended hours will lead to this sign being illuminated for longer.

We are the some concerns regarding the extended opening hours that have been proposed.

We are already affected by the light from the premises. The shop frontage is all glass, with strip lighting and has a big lit fascia so it stands out. The brightness lights up our house like a beacon to such an extent that we have had to purchase black out curtains for the bedrooms at the front of the house to try and keep the light out as much as possible so we can sleep, even with these in place the light gets through at the sides. The idea of now having such intense light pollution for a much longer period is definitely not welcome and will definitely have an impact on our sleep and rest. Once the shop closes for business it still has its lights on to clean and prepare for next days business and so we will be affected longer than the proposed time of closing of 3am.

We live on a busy road and near railway lines and have always accepted noise as part of where we choose to live. Since Top Hut opened for seven days a week we have had added noise and disturbance from their motorcycles and drivers who are constantly out and about doing deliveries. However we have always been guaranteed a reprieve from about 1am onwards when the trains cease to run and the roads are practically empty and the local shops are closed, which is why we did not raise any issues initially regarding opening times. But to extend the opening hours would impact on this and quite frankly we feel it is anti social as well as causing us stress.

The summer is fast approaching and we were already preparing ourselves for the disruption from Top Hut with our windows open but to realise they now want to stay open longer fills us with real dread.

We are not people who usually complain, indeed we are pleased to support local business and respect that Top Hut is obviously being successful but we think that allowing the shop to extend its opening hours as suggested will be detrimental to our lives in many ways and we are not convinced it is a proposal that will benefit anyone in our local community.
