Members are asked to declare any personal interest they have in any item on the agenda.

## 1 Personal interests

There are three types of personal interest referred to in the Council's Member Code of Conduct :-

- (1) Disclosable pecuniary interests
- (2) Other registerable interests
- (3) Non-registerable interests

## 2 Disclosable pecuniary interests are defined by regulation as:-

- (a) <u>Employment,</u> trade, profession or vocation of a relevant person\* for profit or gain
- (b) <u>Sponsorship</u> –payment or provision of any other financial benefit (other than by the Council) within the 12 months prior to giving notice for inclusion in the register in respect of expenses incurred by you in carrying out duties as a member or towards your election expenses (including payment or financial benefit from a Trade Union).
- (c) <u>Undischarged contracts</u> between a relevant person\* (or a firm in which they are a partner or a body corporate in which they are a director, or in the securities of which they have a beneficial interest) and the Council for goods, services or works.
- (d) <u>Beneficial interests in land</u> in the borough.
- (e) <u>Licence to occupy land</u> in the borough for one month or more.
- (f) <u>Corporate tenancies</u> any tenancy, where to the member's knowledge, the Council is landlord and the tenant is a firm in which the relevant person\* is a

partner, a body corporate in which they are a director, or in the securities of which they have a beneficial interest.

- (g) Beneficial interest in securities of a body where:-
  - (a) that body to the member's knowledge has a place of business or land in the borough; and
  - (b) either

(i) the total nominal value of the securities exceeds £25,000 or 1/100 of the total issued share capital of that body; or

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person\* has a beneficial interest exceeds 1/100 of the total issued share capital of that class.

\*A relevant person is the member, their spouse or civil partner, or a person with whom they live as spouse or civil partner.

## (3) Other registerable interests

The Lewisham Member Code of Conduct requires members also to register the following interests:-

- (a) Membership or position of control or management in a body to which you were appointed or nominated by the Council
- (b) Any body exercising functions of a public nature or directed to charitable purposes, or whose principal purposes include the influence of public opinion or policy, including any political party
- (c) Any person from whom you have received a gift or hospitality with an estimated value of at least £25

## (4) Non registerable interests

Occasions may arise when a matter under consideration would or would be likely to affect the wellbeing of a member, their family, friend or close associate more than it would affect the wellbeing of those in the local area generally, but which is not required to be registered in the Register of Members' Interests (for example a matter concerning the closure of a school at which a Member's child attends).

## (5) Declaration and Impact of interest on members' participation

(a) Where a member has any registerable interest in a matter and they are present at a meeting at which that matter is to be discussed, they must declare the nature of the interest at the earliest opportunity and in any

event before the matter is considered. The declaration will be recorded in the minutes of the meeting. If the matter is a disclosable pecuniary interest the member must take not part in consideration of the matter and withdraw from the room before it is considered. They must not seek improperly to influence the decision in any way. <u>Failure to</u> <u>declare such an interest which has not already been entered in the</u> <u>Register of Members' Interests, or participation where such an</u> <u>interest exists, is liable to prosecution and on conviction carries a</u> <u>fine of up to £5000</u>

- (b) Where a member has a registerable interest which falls short of a disclosable pecuniary interest they must still declare the nature of the interest to the meeting at the earliest opportunity and in any event before the matter is considered, but they may stay in the room, participate in consideration of the matter and vote on it unless paragraph (c) below applies.
- (c) Where a member has a registerable interest which falls short of a disclosable pecuniary interest, the member must consider whether a reasonable member of the public in possession of the facts would think that their interest is so significant that it would be likely to impair the member's judgement of the public interest. If so, the member must withdraw and take no part in consideration of the matter nor seek to influence the outcome improperly.
- (d) If a non-registerable interest arises which affects the wellbeing of a member, their, family, friend or close associate more than it would affect those in the local area generally, then the provisions relating to the declarations of interest and withdrawal apply as if it were a registerable interest.
- (e) Decisions relating to declarations of interests are for the member's personal judgement, though in cases of doubt they may wish to seek the advice of the Monitoring Officer.

### (6) Sensitive information

There are special provisions relating to sensitive interests. These are interests the disclosure of which would be likely to expose the member to risk of violence or intimidation where the Monitoring Officer has agreed that such interest need not be registered. Members with such an interest are referred to the Code and advised to seek advice from the Monitoring Officer in advance.

### (7) Exempt categories

There are exemptions to these provisions allowing members to participate in decisions notwithstanding interests that would otherwise prevent them doing so. These include:-

- (a) Housing holding a tenancy or lease with the Council unless the matter relates to your particular tenancy or lease; (subject to arrears exception)
- (b) School meals, school transport and travelling expenses; if you are a parent or guardian of a child in full time education, or a school governor unless the matter relates particularly to the school your child attends or of which you are a governor;
- (c) Statutory sick pay; if you are in receipt
- (d) Allowances, payment or indemnity for members
- (e) Ceremonial honours for members
- (f) Setting Council Tax or precept (subject to arrears exception)

### 1. <u>Current Licence Status</u>

- 1.1 The premises are currently not licensed.
- 1.2 The application for a new premises licence was sent to all the Responsible Authorities. There were no representations from any responsible authorities but six representations were received from residents within relative close proximity to the premises.
- 1.3 The representation received from interested parties, have been examined by Officers and are considered not to be vexatious or frivolous. These representations were all received within the specified time.
- 1.4 The application for the new premises licence has been advertised in Accordance with regulation 39, displayed prominently a notice at the premises, and at the Council's main offices for a period of 28 consecutive days. The last date for receiving representations was the 19<sup>th</sup> June 2019.

### 2. <u>Outline of Application</u>

2.1 The premises are applying for:

Sale of alcohol for consumption ON the premises 08:00 – 02:00 Monday – Sunday.

## 3. Outline of objections received

Residents are objecting to the premises opening until from 8am until 2am every day due to perceived noise and associated anti-social behaviour. The objection has been sought on the grounds of prevention of a public nuisance.

## 4. Legal and Human Rights Implications

- 4.1 The Licensing authority is a public authority under the Human Rights Act 1998. Therefore the licensing authority is required to act compatibly with the convention rights in the exercise of their functions. 3.2 Article 6 (1) of the Convention provides that everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial hearing established by law.
- 4.2 A Premises Licence is a possession for the purpose of the Human Rights Act 1998. The right to hold a licence is a qualified rather than an absolute right. Therefore the right to hold a licence may be interfered with if it affects the interests of local residents or others. Such interference may be justified if it is necessary and proportionate to promote the licensing objectives.

## 5. Equalities Implications

- 5.1 The Equality Act 2010 includes a new public sector equality duty (the equality duty or duties). The duty covers the following nine protected characteristics: age, disability, gender reassignment, marriage and civil partnerships, pregnancy and maternity, race or religion or belief, sex and sexual orientation.
- 5.2 In summary the Council must, in the exercise of its functions, have due regard to the need to:
  - eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Act;
  - advance equality of opportunity between people who share a protected characteristic and those who do not;
  - Foster good relations between those who share a protected characteristic and those who do not.
- 5.3 As with the case with the original separate duties, the new duty continues to be a "have regard duty" and the weight to attach to it is a matter for the committee bearing in mind the relevance and proportionality. It is not an absolute requirement to eliminate discrimination, advance equality of opportunity or foster good relations.

## 6. Application for the New Premises Licence

After having regard to all representations, Members must take such steps as they consider necessary for the promotion of the licensing objectives. The licensing committee may: (a)grant the licence subject to-

(i)the conditions which must under section 19, 20 or 21 [of the Licensing Act 2003, as amended be included in the licence;

(b)exclude from the scope of the licence any of the licensable activities to which the application relates;

(c)refuse to specify a person in the licence as the premises supervisor;

(d)to reject the application.

An appeal may be made against the decision to the Magistrates Court within 21days.

As a resident of Deptford high street, I am writing to strongly oppose the late music and alcohol license application by Kick N Munch at 189 Deptford High Street, SE8 3NT, on the grounds that it will cause a significant noise disturbance to myself and others, and for the following reasons...

- . The application is to play music and serve alcohol license every day of the week until 2am. I am freelance in the video industry and often work long and unpredictable hours, both on location and at home. If I am unable to work or sleep due to noise this would be extremely detrimental to my work, health and wellbeing. The same would apply to anyone else working similar hours, or indeed a standard working week.
- The location is a residential area. There are no other late license bars anywhere on the north end of the high street (the nearest to my knowledge being Buster Mantis in the arches by Deptford Station). A late license would undoubtably be very disruptive to the residents on the high street, nearby and anywhere within earshot. Music carries a long way in this part of the high street as the parallel buildings create a corridor that channels the sound a long way down. There are many people and properties along the high street that would be affected like mine.
- Disruption would not be limited to music alone. A late music and alcohol license would also create a hub for people to hang around outside, both during and after closing hours. It's fair to say that drunk people are very loud and inconsiderate and often shout, scream and argue with each other. Even if efforts were made to stop people congregating outside, they likely still would regardless. Generally speaking, anytime anyone goes in or out of a loud venue, sound projects outwards through the doors. Also, people would undoubtedly make a lot of noise when leaving the venue at the end of the night, causing the biggest disruption at the latest part of the night at 02.00-02.30am. There's no telling how long they would hang around outside before moving on and the bar would likely have little authority to move people on. Disruption would be heightened in the summer months when people have their windows open at night and during the evenings.
- Granting this late license would set a precedence and make it very difficult to refuse other applications for late license bars at this part of the high street. Before long there could be numerous other late license bars and this would transform the whole stretch of the high street from a quiet

residential area to a nightclub party destination with very destructive consequences for the area. Albury Street is one of, if not the oldest street in Deptford with beautiful listed properties that are highly sought after, so much so that many tours of Deptford feature this as a highlight. A nightlife culture would undoubtably tarnish this, the quality of life of the residents and the value of the properties in this area. It would make people think twice about moving to the area and might make existing residents move also.

Please consider this objection very seriously. It would make life very difficult for myself and the many residents affected, and I am sure the bar would also find it difficult if there are constant noise complaints. A significant amount of the Lewisham Council's time and resources could also be consumed by dealing with these complaints.

I hope and trust that you will take action in favour of the many affected residents of the area.

We write to object to the application for a new premises licence at No. 189 Deptford High Street.

We are residents who live and work close to the premises, Our objections are as follows:

### 1. Protection of Children from Harm

The noise created from customers leaving a venue after drinking until 2am or even 3am, as they walk down the street will disturb the sleep of our children, aged 9 and 12, (whose bedroom overlooks the High St), and indeed of other families who live in the area. We are also concerned that recorded music from the venue itself will disturb sleep.

We already have interruptions to our family's sleep from people walking along the High Street talking noisily at earlier hours of the evening, up until about 11pm, and so it will be extremely detrimental to our and our neighbours' lives if those kind of interruptions extend even later - especially after completing a lengthy session of drinking, when people are likely to be more careless about noise. As it is, we notice our children find it hard to get up in the mornings when there has been a particular noisy evening. It is actually hard to put into words how upsetting it is when one is not in a position to protect the sleep of your children, which one knows is so essential to their health and wellbeing.

Please note, the problem is exacerbated on this High Street because it is very narrow and so sound tends to rebound off the two faces of the terraces and is experienced very loudly in the upper parts of the buildings.

We would also like to emphasise that Deptford High Street is a densely occupied, residential street, just as much as it is a trading and retail street, and we know of several different families with children living above shops. Until recently the High Street has had next to no late night drinking venues and is mainly a retail street, and so I hope the Licensing Team realise it will materially affect the lives and health of children living here if this license is allowed.

### 2. Prevention of Public Nuisance

Late night drinking gives customers the opportunity to become significantly more affected by alcohol over a longer time. As things stand the High Street already suffers from urination in doorways and against walls, loud noises and arguments in the evening, fast food litter, graffiti and even some vomiting. We therefore object to this license for late night drinking, because it will add to the likelihood of that happening and of it happening later in the evening than it currently does. We also notice that the High Street is short of public toilets which can be accessed in the evenings, causing people to use the side streets.

In this case the hours asked for and the numbers of days of the week asked for are excessive and unnecessary, especially in a residential area.

### 3. Public Safety

Deptford High Street has a history of street drinking problems and indeed some violence and aggressive behaviour and we therefore object to a licence that will bring about more people being on the High St in the early hours after drinking for a long period. When our sleep has been interrupted in the past, we have on occasion leant, or even stepped, outside to ask for people to be quieter and have frequently met with unpleasant responses that make us feel unsafe. We therefore object to any late alcohol license that adds to the possibility of that happening. Again we emphasise that this street is currently not characterised as a drinking street but is largely a retail and residential one, which is a safer environment and should be preserved as such.

### 4. Prevention of Crime and Disorder

We believe that granting this licence will provide people with a reason to be on Deptford High Street, after a long drinking session when they otherwise would not do so, which surely increases the risk of disorder and possibly crime. Given the existing mixed residential/retail use of the High Street, we think that should be protected from anything that might encourage such disorder.

Lastly, I note that the applicant has considered applying for earlier closing hours of midnight and 1am, instead of the later times started in the notice. However our concerns laid out above all still apply, as children and residents need sleep and safe and secure streets before midnight.

Thank you for considering these objections.

#### 1. <u>Notice content</u>

- 1.1 The Temporary Event Notice is for the following activity to take place From 19:00 on 3<sup>rd</sup> August 2019 until 01:00am on 4th August 2019.
- 1.2 The provision of regulated entertainment from 19:00 until 01:00 The Sales by retail of alcohol from 19:00 until 01:00 for a birthday party.
- 1.3 The notice was served on the Metropolitan Police (MPS) and the London Borough of Lewisham Crime, Enforcement and Regulation Service. An objection were received from the Crime Enforcement & Regulation Service within the specified time limit in accordance with section 104 of the Licensing Act 2003. The objection was received in relation to preventing a public nuisance due to an ongoing noise nuisance case.
- 1.4 The premises currently has a licence for sale by retail of alcohol on and off the premises 17:00 22:00 Tuesday to Thursday and 12:00 22:00 Friday to Sunday.

## 2. Legal and Human Rights Implications.

- 2.1 Where an objection notice is received following a Temporary Event Notice a licensing authority is required to hold a hearing. In this case the Licensing Authority is required to consider whether the proposed temporary event will promote the crime prevention and public nuisance licensing objectives.
- 2.2 The licensing authority is a public authority under the Human Rights Act 1998. Therefore the Licensing Authority is under a duty to act compatibly with Convention Rights in the exercise of their function. Article 6 (1) of the Convention provides that everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial hearing established by law.
- 2.3 The right to give a Temporary Event Notice falls within the scope of civil rights and obligations in Article 6 (1) as it relates, in this case, to a Premises Licence holder's right to pursue commercial activity. This right is a qualified right therefore it may be interfered with if it is appropriate to protect the general interest of the community.

## 3. Equalities Implications

- 3.1 The Equality Act 2010 includes a new public sector equality duty (the equality duty or duties) the duty covers the following nine protected characteristics: age, disability, gender reassignment, marriage and civil partnerships, pregnancy and maternity, race or religion or belief, sex and sexual orientation.
- 3.2 In summary the Council must, in the exercise of its functions, have due regard to the need to-

-eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Act -advance equality of opportunity between people who share a protected characteristic and those who do not -foster good relations between those who share a protected characteristic and those who do not

3.3 As with the case with the original separate duties, the new duty continues to be a "have regard duty" and the weight to attach to it is a matter for the committee bearing in mind the relevance and proportionality. It is not an absolute requirement to eliminate discrimination, advance equality of opportunity or foster good relations.

## 4. Determination of Objection Notice

- 4.1 After having regard to all the representations heard, Members must take such steps as they consider appropriate to promote the prevention of crime and disorder and public nuisance. Therefore the Licensing Committee may;
  - 1. Decide no action is appropriate to promote the prevention of crime and disorder and public nuisance therefore the temporary event may go ahead OR
  - 2. Impose one or more conditions on the standard temporary event notice if
    - a. the authority considers it appropriate for the promotion of the licensing objectives to do so,
    - b. the conditions are also imposed on a premises licence or club premises certificate that has effect in respect of the same premises, or any part of the same premises, as the standard temporary event notice, and
    - c. the conditions would not be inconsistent with the carrying of licensable activities under the standard temporary event notice
  - 3. Issue a counter notice if it considers it is appropriate to promote the licensing objectives, therefore the temporary event may not go ahead
- 4.2 There is a right of appeal to the Magistrates Court against a decision either to give a counter notice or to allow the temporary event to go ahead.
