#### **Outline and recommendations**

Members are asked to declare any personal interest they have in any item on the agenda.

### 1. Summary

- 1.1. Members must declare any personal interest they have in any item on the agenda. There are three types of personal interest referred to in the Council's Member Code of Conduct:
  - (1) Disclosable pecuniary interests
  - (2) Other registerable interests
  - (3) Non-registerable interests.
- 1.2. Further information on these is provided in the body of this report.

#### 2. Recommendation

2.1. Members are asked to declare any personal interest they have in any item on the agenda.

### 3. Disclosable pecuniary interests

- 3.1 These are defined by regulation as:
  - (a) Employment, trade, profession or vocation of a relevant person\* for profit or gain
  - (b) Sponsorship –payment or provision of any other financial benefit (other than by the Council) within the 12 months prior to giving notice for inclusion in the register in respect of expenses incurred by you in carrying out duties as a member or towards your election expenses (including payment or financial benefit from a Trade Union).
  - (c) <u>Undischarged contracts</u> between a relevant person\* (or a firm in which they are a partner or a body corporate in which they are a director, or in the securities of which they have a beneficial interest) and the Council for goods, services or works.
  - (d) <u>Beneficial interests in land</u> in the borough.
  - (e) <u>Licence to occupy land</u> in the borough for one month or more.
  - (f) <u>Corporate tenancies</u> any tenancy, where to the member's knowledge, the Council is landlord and the tenant is a firm in which the relevant person\* is a partner, a body corporate in which they are a director, or in the securities of which they have a beneficial interest.
  - (g) <u>Beneficial interest in securities</u> of a body where:
    - (a) that body to the member's knowledge has a place of business or land in the borough; and
    - (b) either:
      - (i) the total nominal value of the securities exceeds £25,000 or 1/100 of the total issued share capital of that body; or
      - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person\* has a beneficial interest exceeds 1/100 of the total issued share capital of that class.
      - \*A relevant person is the member, their spouse or civil partner, or a person with whom they live as spouse or civil partner.

### 4. Other registerable interests

- 4.1 The Lewisham Member Code of Conduct requires members also to register the following interests:
  - (a) Membership or position of control or management in a body to which you were appointed or nominated by the Council
  - (b) Any body exercising functions of a public nature or directed to charitable purposes, or whose principal purposes include the influence of public opinion or policy, including any political party
  - (c) Any person from whom you have received a gift or hospitality with an estimated value of at least £25.

#### 5. Non registerable interests

5.1. Occasions may arise when a matter under consideration would or would be likely to affect the wellbeing of a member, their family, friend or close associate more than it would affect the wellbeing of those in the local area generally, but which is not required to be registered in the Register of Members' Interests (for example a matter concerning the closure of a school at which a Member's child attends).

#### 6. Declaration and impact of interest on members' participation

- 6.1. Where a member has any registerable interest in a matter and they are present at a meeting at which that matter is to be discussed, they must declare the nature of the interest at the earliest opportunity and in any event before the matter is considered. The declaration will be recorded in the minutes of the meeting. If the matter is a disclosable pecuniary interest the member must take not part in consideration of the matter and withdraw from the room before it is considered. They must not seek improperly to influence the decision in any way. Failure to declare such an interest which has not already been entered in the Register of Members' Interests, or participation where such an interest exists, is liable to prosecution and on conviction carries a fine of up to £5000
- 6.2. Where a member has a registerable interest which falls short of a disclosable pecuniary interest they must still declare the nature of the interest to the meeting at the earliest opportunity and in any event before the matter is considered, but they may stay in the room, participate in consideration of the matter and vote on it unless paragraph 6.3 below applies.
- 6.3. Where a member has a registerable interest which falls short of a disclosable pecuniary interest, the member must consider whether a reasonable member of the public in possession of the facts would think that their interest is so significant that it would be likely to impair the member's judgement of the public interest. If so, the member must withdraw and take no part in consideration of the matter nor seek to influence the outcome improperly.
- 6.4. If a non-registerable interest arises which affects the wellbeing of a member, their, family, friend or close associate more than it would affect those in the local area generally, then the provisions relating to the declarations of interest and withdrawal apply as if it were a registerable interest.
- 6.5. Decisions relating to declarations of interests are for the member's personal judgement, though in cases of doubt they may wish to seek the advice of the Monitoring Officer.

#### 7. Sensitive information

7.1. There are special provisions relating to sensitive interests. These are interests the disclosure of which would be likely to expose the member to risk of violence or intimidation where the Monitoring Officer has agreed that such interest need not be registered. Members with such an interest are referred to the Code and advised to seek advice from the Monitoring Officer in advance.

### 8. Exempt categories

- 8.1. There are exemptions to these provisions allowing members to participate in decisions notwithstanding interests that would otherwise prevent them doing so. These include:-
  - (a) Housing holding a tenancy or lease with the Council unless the matter relates to your particular tenancy or lease; (subject to arrears exception)
  - (b) School meals, school transport and travelling expenses; if you are a parent or

guardian of a child in full time education, or a school governor unless the matter relates particularly to the school your child attends or of which you are a governor

- (c) Statutory sick pay; if you are in receipt
- (d) Allowances, payment or indemnity for members
- (e) Ceremonial honours for members
- (f) Setting Council Tax or precept (subject to arrears exception).

#### **Outline and recommendations**

Determination of Full Variation Application - After having regard to all the representations heard, Members must take such steps as they consider appropriate to promote the Licensing Objectives. The Licensing Committee's powers are set out in the paragraph below, titled 'Recommendations'

### Timeline of engagement and decision-making

The Application was advertised in accordance with regulation 25 of the Licensing Act 2003.

The last day for representations was 19 May 2020.

This matter must be heard with 20 days from the day after the last day of representations (this hearing was postponed due to the Covid 19 pandemic in the public interest to be held by remote hearing on 18 June 2020).

### 1. Summary

1.1 The premises is currnetly licenced for the following activities:

Provision of late night refreshment

23.00 - 02.00 Monday

23.00 - 02.00 Tuesday

23.00 - 02.00 Wednesday

23.00 - 02.00 Thursday

23.00 - 03.00 Friday

23.00 - 03.00 Saturday

23.00 - 02.00 Sunday

1.2 The particulars applied for under the Full Variation application are:

To Add Alcohol sales for delivery, collection and take away only

11:00 - 02:00 Sunday - Thursday

11:00 - 03:00 Friday & Saturday

- 1.3 Representations were received from five interested persons living nearby and all representations made on grounds of all four licensing objectives. The representations received from interested parties have been examined by Officers and are considered not to be vexatious or frivolous. These representations were all received within the specified time.
- 1.4 Conditions were agreed between the applicant, Police and Crime, Enforcement & Regulation Service to promote licensing objectives.

#### 2. Recommendations

- 2.1 After having regard to all the representations heard, Members must take such steps as they consider appropriate to promote the licensing objectives. The steps available to the Licensing Authority:
  - (a) to modify the conditions of the licence; or
  - (b) to reject the whole or part of the application.

and for this purpose, the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

2.2 There is a right of appeal to the Magistrates Court against a decision either to give a counter notice or to allow the temporary event to go ahead.

### 3. Policy Context

- 3.1 Decisions by Members of the Licensing Committee should have regard to the Licensing Act 2003 and the promotion of the four Licensing Objectives at all times, which includes the following:
  - Protection of Children from Harm
  - Preventin of Crime and Disorder
  - Prevention of Public Nuisnace

- Public Safety
- 3.2 Members should also have regard to the Licensing Authority's Statement Licensing Policy 2015-19.
- 3.3 Decisions made will link in with the following objectives under the Council's Corporate Stategy Building an Inclusive Local Economy and Building Safer Communities.

### 4. Financial implications

4.1 Applicants have the right of appeal against any decision by the Licensing Committee. Therefore there would likely be costs for the Authority in seeking legal support should an appeal be brought by the applicant.

### 5. Legal implications

- 5.1 The Licensing Authority is a public authority under the Human Rights Act 1998. Therefore the licensing authority is required to act compatibly with the convention rights in the exercise of their functions. Article 6 (1) of the Convention provides that everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial hearing established by law.
- 5.2 A Premises Licence is a possession for the purpose of the Human Rights Act 1998. The right to hold a licence is a qualified rather than an absolute right. Therefore the right to hold a licence may be interfered with if it affects the interests of local residents or others. Such interference may be justified if it is necessary and proportionate to promote the licensing objectives.

### 6. Equalities implications

- 6.1 The Equality Act 2010 (the Act) introduced a public sector equality duty (the equality duty or the duty). It covers the following protected characteristics: age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation.
- 6.2 In summary, the Council must, in the exercise of its functions, have due regard to the need to:
  - eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Act.
  - advance equality of opportunity between people who share a protected characteristic and those who do not.
  - foster good relations between people who share a protected characteristic and those who do not.
- 6.3 It is not an absolute requirement to eliminate unlawful discrimination, harassment, victimisation or other prohibited conduct, or to promote equality of opportunity or foster good relations between persons who share a protected characteristic and those who do not. It is a duty to have due regard to the need to achieve the goals listed above.
- 6.4 The weight to be attached to the duty will be dependent on the nature of the decision and the circumstances in which it is made. This is a matter for the Mayor, bearing in mind the issues of relevance and proportionality. The Mayor must

understand the impact or likely impact of the decision on those with protected characteristics who are potentially affected by the decision. The extent of the duty will necessarily vary from case to case and due regard is such regard as is appropriate in all the circumstances.

6.5 The Equality and Human Rights Commission has issued Technical Guidance on the Public Sector Equality Duty and statutory guidance entitled "Equality Act 2010 Services, Public Functions & Associations Statutory Code of Practice". The Council must have regard to the statutory code in so far as it relates to the duty and attention is drawn to Chapter 11 which deals particularly with the equality duty. The Technical Guidance also covers what public authorities should do to meet the duty. This includes steps that are legally required, as well as recommended actions. The guidance does not have statutory force but nonetheless regard should be had to it, as failure to do so without compelling reason would be of evidential value. - 6.6 The Equality and Human Rights Commission (EHRC) has previously issued five guides for public authorities in England giving advice on the equality duty:

  - Meeting the equality duty in policy and decision-making
  - Engagement and the equality duty: A guide for public authorities
  - Objectives and the equality duty. A guide for public authorities
  - Equality Information and the Equality Duty: A Guide for Public Authorities
- 6.7 The essential guide provides an overview of the equality duty requirements including the general equality duty, the specific duties and who they apply to. It covers what public authorities should do to meet the duty including steps that are legally required, as well as recommended actions. The other four documents provide more detailed guidance on key areas and advice on good practice. Further information and resources are available at:

### 7. Climate change and environmental implications

This will include how meetings are to be held, restrictions on the freedom of movement and social distancing strictures and the power to enable police to attend meetings remotely. Therefore decisions by Members of the Licensing Committee will have regard to:

   During The Covid 19 Pandemic, 8 April 20 (Update 2);
- Approaches to Managing Licensing and Related Issues During The Covid 19 Pandemic Guidance;
- The Health Protection (Coronavirus, Restrictions) (England) Regulations 2020;
- The Local Authorities and Police And Crime Panels (Coronavirus) (Flexibility Of Local Authorities and Police And Crime Panel Meetings) (England and Wales) Regulations 2020;

Applicant	A person who carries on, or proposes to carry on, a business which involves the use of a premises for licensable activities to which the application relates or, a person who makes an application pursuant to any statutory function discharged by that person relating to those licensable activities, or a person who applies for the grant of a Personal Licence from a Licensing Authority.
Designated Premises Supervisor	The person named on the Premises Licence as being the person with ultimate responsibility for the running of the premises. He or she must hold a Personal Licence. There can only be one Designated Premises Supervisor for each premises.

Licence	an authority to do something.
Licence Objectives	Under section 4 of the 2003 Act the Licensing Authority must promote the following 4 objectives:  • Prevention of crime and disorder  • Public safety  • Prevention of public nuisance  • Protection of children from harm

Variation	Application to make changes to an existing premises licence. A full variation is one that is deemed could negatively impact on licensing objectives and therefore requires a full 28 day consultation process.

The premises shall install and maintain a comprehensive CCTV system. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available upon the request of Police or Local Authority throughout the preceding 31 day period, such copies shall in any event be provided within forty-eight (48) hours.

I have previously written you to raise my strong objection to the alcohol license Fantastic Morley's has applied for. My original objection stands unchanged, and therefore I am repeating my objection in writing.

I am writing to you about the licensing application for this chicken shop to sell alcohol from their premises. I very strongly object to the licensing application to sell alcohol from this premises, and even more during the very late hours it has applied for, namely, Sunday-Thursday 1100-0200 and Friday-Saturday 1100-0300.

The shop is located in a heavily residential area, with a lot of families with young infants and children in the streets immediately around the shop. I personally have an 11-month-old boy, and both my neighbours on either side have children aged between 1 and 6.

The chicken shop already causes a nuisance in the area, as there is constant littering of food packaging outside the shop and up the street; discarded food which attracts foxes and vermin; and their customers parking on red lines whilst going in to order, which is a safety hazard for people crossing the road and drivers entering or exiting the street.

In granting this license there will be a huge detriment to the:

- Prevention of Crime and Disorder
- Prevention of Public Nuisance
- Protection of Children from Harm
- Public Safety

The granting of an alcohol license, and a late-night one at that, will surely draw in late-night and likely inebriated revellers. This will exacerbate the issue of littering, noise and anti-social behaviour when families are likely to be disturbed as they are asleep.

There is no existing late-night leisure activity in the area, which is something I want to be maintained. The street already has a massive problem with fly-tipping and overflowing bins, specifically on Ravensbourne Road at the shop. I have often reported fly-tipping through Fix My Street App. I also have felt unsafe coming home, specifically after dusk, when there are people hanging out on the street outside the shop and near the dark pathway to the flats above the shops.

Re: Fantastic Morley's Chicken, 307 Stanstead Road – my objection to their application to add alcohol sales for delivery, collection and take away.

I strongly object to the shop's application for a variation of licence to sell alcohol during Sunday-Thursday 1100-0200 and Friday-Saturday 1100-0300. Granting this licence would be a huge detriment to my personal safety, health and wellbeing (and that of other local residents) and undermine the Council's aims to promote the four licensing objectives set out in the Licensing Act

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm

as follows: The shop is the middle of a family-orientated, diverse, residential area which includes vulnerable groups such as older people, people living with disabilities, single residents and families with young children. I live on my own and am hugely concerned about prevention of crime and disorder to keep myself safe. The granting of an alcohol license, particularly late at night, will increase to the area late night revellers, result in inebriated customers, and so lead to greater propensity for crime and disorder, which puts my personal safety and wellbeing at risk. Living on my own, the prospect makes me feel very vulnerable.

The Stansted Road end of Ravensbourne Road already has multiple public health and safety problems (e.g. fly-tipping, low level drug dealing and overflowing bins). I am deeply concerned that by granting the licence, this would get even worse. As co-chair of our local community group (Blythe Hill Action Group), I have personally worked hard to make the area cleaner, greener and safer for vulnerable residents through community clean-up days, by raising funds for tree planting and combating nuisance behaviour. Granting the application would undermine what I am trying to do for our community. It would be a source of new and additional public nuisance (such as littering, noise and anti-social behaviour) up until 2am weekdays and 3am on the weekend. As a single person and woman, I would not feel safe to challenge such behaviour and worry deeply about the effect this would have on my/community safety, the quality of my sleep and my overall mental wellbeing. I am a hard working public servant whose performance depends on good sleep, a safe home and a welcoming, safe, neighbourhood.

Already, there are ample problems in the immediate vicinity of the chicken shop. I have found syringes, drinking and drugs paraphernalia in its vicinity. The street corner (Ravensbourne / Stansted Road) is believed to be a site of night time drug dealing, which our councillors are also trying to get under control with public health measures. A late night alcohol license would undoubtedly undermine this; it would further facilitate nuisance to me, increase crime and endanger my and other residents', including children's, safety.

The area around Stansted Road/Ravensbourne Road is a historically deprived area with the active involvement of multiple stakeholders to improve it. We have a good primary school, a children's book shop, a post office, grocers and a fantastic friendly local pub that closes at proper hours. There is no need for the chicken shop to start selling alcohol – in my view, it'd add no value whatsoever to the area; rather, would cause nothing but problems for residents such as myself and add ill-affordable cost from our council tax contributions to policing and already stretched council services. You stipulate engines must be turned off, but in reality who will police this? Even worse than this, you stipulate that motorbikes must not park outside directly outside the premises. In that case they will most likely drive into Ravensbourne Road and park further up in our residential street. This will be of great public nuisance in noise and add to the air and noise pollution to residents.

We strongly object to the licensing application to sell alcohol from this premises Sunday-Thursday 1100-0200 and Friday-Saturday 1100-0300.

The premises is right in the middle of a family orientated residential area populated by families with young children. We are a young family with a two year old daughter and I'm pregnant expecting this autumn.

The granting of an alcohol license and a late night one at that is highly likely to act as a beacon for late night revellers, likely inebriated and likely to be a source of littering, noise and anti-social behaviour up <u>until 2a</u>m weekdays and 3am on the weekend. It will be a huge detriment to the:

Prevention of Crime and Disorder Prevention of Public Nuisance Protection of Children from Harm Public Safety

We are a hardworking family, moved to this area two years ago as an up and coming, family orientated neighbourhood in close proximity to green spaces and outstanding primary schools. There is no existing late night leisure activity in the area and that is something we wish to be maintained. We already have personal problems with fly-tipping and overflowing bins in the area and we personally have been working hard to make the area cleaner, greener and more family friendly by raising funds for tree planting and combating nuisance behaviour in connection with the council and our local MP Vicky Foxcroft who we will be writing to about this as well. The granting of a late night alcohol license to the chicken shop in our residential area and close to our home, will undermine efforts to make the area cleaner and greener, and detrimentally affect our family's quality of life by increasing nuisance, crime, littering, anti-social behaviour and making the area unsafe for our children. We have already found syringes, drinking and drugs paraphernalia in the vicinity of the chicken shop and the street corner is believed locally to be a site of night time drug dealing (I believe that is why a surveillance camera was recently installed on the street lamp at this junction), it is not therefore the ideal premises or site for a late nights alcohol license, which will further facilitate nuisance and crime.

We work very hard and both adults in our household work full time and so our time at home with our child and family is precious We do not wish this to be disturbed by late night revelry that would be more appropriate in an area that has already established late night leisure facilities. Not in our area - with an outstanding primary school, a children's book shop, a post office, grocers and a friendly local pub that closes at proper hours.

The granting of this license will severely negatively affect our quality of life as a young family and is likely to increase crime and disorder, nuisance, make the environment more harmful to children and unsafe for families and residents in the area like ours.

1.2. The particulars applied for under the Full Variation application are:

Extension of current hours for the following licensable activities:

Provision of regulated entertainment (Recorded Music)

10:00 – 01:00 Thursday to Saturday

Alcohol for consumption ON and OFF the Premises

10:00 – 01:00 Thursday to Saturday

Late Night Refreshment

23:00 - 01:30 Thursday to Saturday

And an additional 2 hours on New Year's Eve.

- 1.3. Representations were received from one interested person living nearby and also from the Deptford Society representing residents in the area. Both representations were made on grounds of public nuisance. The representations received from interested parties have been examined by Officers and are considered not to be vexatious or frivolous. These representations were all received within the specified time.
- 1.4. Conditions were agreed between the applicant, Police and Crime, Enforcement & Regulation Service to promote licensing objectives.

#### 2. Recommendations

- 2.1 After having regard to all the representations heard, Members must take such steps as they consider appropriate to promote the licensing objectives. The steps available to the Licensing Authority:
  - (a) to modify the conditions of the licence;
  - (b) to reject the whole or part of the application.
- 2.2 There is a right of appeal to the Magistrates Court against a decision either to give a counter notice or to allow the temporary event to go ahead.

# 3. Policy Context

3.1. Decisions by Members of the Licensing Committee should have regard to the Licensing Act 2003 and the promotion of the four Licensing Objectives at all

times, which includes the following:

- Protection of Children from Harm
- Preventin of Crime and Disorder
- Prevention of Public Nuisnace
- Public Safety
- 3.2. Members should also have regard to the Licensing Authority's Statement Licensing Policy 2015-19.
- 3.3. Decisions made will link in with the following objectives under the Council's Corporate Stategy Building an Inclusive Local Economy and Building Safer Communities.

# 4. Financial implications

4.1. Applicants have the right of appeal against any decision by the Licensing Committee. Therefore there would likely be costs for the Authority in seeking legal support should an appeal be brought by the applicant.

# 5. Legal implications

- 5.1 The Licensing Authority is a public authority under the Human Rights Act 1998. Therefore the licensing authority is required to act compatibly with the convention rights in the exercise of their functions. Article 6 (1) of the Convention provides that everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial hearing established by law.
- 5.2 A Premises Licence is a possession for the purpose of the Human Rights Act 1998. The right to hold a licence is a qualified rather than an absolute right. Therefore the right to hold a licence may be interfered with if it affects the interests of local residents or others. Such interference may be justified if it is necessary and proportionate to promote the licensing objectives.

# 6. Equalities implications

- 6.1 The Equality Act 2010 (the Act) introduced a public sector equality duty (the equality duty or the duty). It covers the following protected characteristics: age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation.
- 6.2 In summary, the Council must, in the exercise of its functions, have due regard to the need to:
  - eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Act.
  - advance equality of opportunity between people who share a protected characteristic and those who do not.
  - foster good relations between people who share a protected characteristic and those who do not.
- 6.3 It is not an absolute requirement to eliminate unlawful discrimination, harassment, victimisation or other prohibited conduct, or to promote equality of opportunity or foster good relations between persons who share a protected characteristic and

those who do not. It is a duty to have due regard to the need to achieve the goals listed above.

- 6.4 The weight to be attached to the duty will be dependent on the nature of the decision and the circumstances in which it is made. This is a matter for the Mayor, bearing in mind the issues of relevance and proportionality. The Mayor must understand the impact or likely impact of the decision on those with protected characteristics who are potentially affected by the decision. The extent of the duty will necessarily vary from case to case and due regard is such regard as is appropriate in all the circumstances.
- 6.5 The Equality and Human Rights Commission has issued Technical Guidance on the Public Sector Equality Duty and statutory guidance entitled "Equality Act 2010 Services, Public Functions & Associations Statutory Code of Practice". The Council must have regard to the statutory code in so far as it relates to the duty and attention is drawn to Chapter 11 which deals particularly with the equality duty. The Technical Guidance also covers what public authorities should do to meet the duty. This includes steps that are legally required, as well as recommended actions. The guidance does not have statutory force but nonetheless regard should be had to it, as failure to do so without compelling reason would be of evidential value. - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
  wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not

## **Annex 1- Mandatory conditions**

Mandatory conditions are in accordance as set out in the Licensing Act 2003 as amended by the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 and Order 2014 or as may be amended from time to time.

No supply of alcohol may be made under the Premises Licence.

- (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
- **(b)** At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.

Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:

- (a) a holographic mark or
- (b) an ultraviolet feature.
- **1.** A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph I
- (a) "Duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
- **(b)** "Permitted price" is the price found by applying the formula P = D + (DXV)

Where -

- (i)P is the permitted price
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- **(c)** "Relevant person" means, in relation to premises in respect of which there is in force a premises licence
- (i) The holder of the premises licence
- (ii) The designated premises supervisor (if any) in respect of such a licence, or
- (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;

- **(d)** "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- **(e)** "Value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- **3.** Where the permitted price given by Paragraph **(b)** of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- **4. (1)** Sub-paragraph **(2)** applies where the permitted price given by Paragraph **(b)** of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2-Conditions consistent with the operating Schedule

An approved CCTV system to be maintained inside of the premises with a 31 day retention of recordings. The system must comply with BSEN 50132 (part7) 2009 and be capable of facial image recognition of all persons both entering and leaving the premises. The cameras will cover the whole of the premises and true copies be retained for 31 days, such copies must be in a format that can be viewed on readily available equipment without the need for specialist software and made available upon request to MPS and LA officers. One member of staff on duty at the premises must be capable of operating at all times.

Dear Sir or Madam,

We are writing on behalf of the Deptford Society to submit an objection to the application for a full variation to the existing licence at the Job Centre Pub.

The Deptford Society is the local amenity group for the Deptford High St and Creekside Conservation Areas. Our members are long-term residents, business owners and representatives of other interested groups who live and work within the conservation areas and the adjoining streets.

The applicant is seeking a full variation to its existing licence for Provision of Regulated Entertainment (Recorded Music), Alcohol for Consumption On and Off the Premises until 1am Thursday to Saturday and for Late Night Refreshment until 1.30am Thursday to Saturday. This represents an hour of extra trading Thursday to Saturday.

The Deptford Society objects to this application on the grounds of prevention of public nuisance. We believe that granting extended hours and having patrons exiting the premises after 1am Thursday to Saturday will have a detrimental impact on the reasonable sleeping patterns of the many people who live next to, behind, opposite and around the premises. No matter how well managed a licensed premises is, staff cannot influence the behaviour of patrons once they leave the premises and disperse along the high street and adjacent streets. We believe the current licensed hours are already beyond what is appropriate for the same reasons and suggest that this application for extended hours be refused.

It is important to point out that although Deptford High St has the appearance of a commercial high street at ground level, the upper levels are home to a residential population in a density comparable to any suburban street.

These households range from singles and couples to larger shared and family households, many of whom are long-term residents. At night time Deptford High St, with its low volume of traffic (which has decreased further since recent alterations to the road system) has a low level of ambient noise, making it an attractive place to live. This fact transforms Lewisham Council's responsibility to deliver the licensing objectives since these residents have a legal right to protection from statutory nuisance, as set out in the Environmental Health Act 1990. Night-time noise that is likely to disturb sleep is a consideration under this act, due to its obvious detrimental effects on health and well-being.

The Deptford Society is concerned that this distinction should be properly recognised when planning and licensing decisions are being taken. Over the last year, largely due to the disjointed and unreliable procedure for notifying residents of applications, licences have been issued to premises that are surrounded by residential dwellings to allow them to open late on weekends, some until 1am and in one case, until 3am. We are concerned that these late hours are being regarded as a precedent by other applicants, with the potential for an increase in late-night licensing and a consequent increase in public nuisance to those who live on and around the high street.

The Deptford Society supports the development of Deptford's night-time economy, and welcomes the arrival of new bars and restaurants in the high street, but seeks to ensure that the correct balance is struck between commercial demands and the needs of residents, to enable them to continue to co-exist successfully; the increase in licenced premises should not

come at the expense of the people who have made their homes here and who contribute so much to the unique character of Deptford.

If the opening hours are extended this will mean that this noise will be extended in to the early hours of the morning when residents will be trying to sleep. The longer opening hours will most probably also result in customers who have drunk more and therefore be louder. In my experience if an establishment is open later people then flock to this place to continue drinking after earlier shutting places close.

I am aware of people going outside to smoke and have conversations at the front of the building, directly below my living room and bedroom. Even if they do not have a drink with them they often converse loudly. If this is to happen later and later it will become more of a disturbance.

It is indeed great that no one has felt the need to complain recently which proves that these opening hours are working for local residents. I would hate this to change if the opening hours are extended.

I know that some of the other residents in my building have concerns about the smioking area and noise coming from that but sadly when that is closed people then come out the front which is not good for the residents at the front of the building.

I don't think there is any way that they can stay open later and not allow people outside to smoke and talk (loudly) which is another reason why I really don't want the hours to be extended.
