The Crime, Enforcement and Regulation Service seeks an application for review of the premises referred to as Pizza 2 Night, 26A Catford Hill, Catford, London SE6 4PX.

On the 19 February 2019 at approx. 04:18, my colleague Denis Savin and I were providing an out of hours noise service, while driving down Catford Hill a male was observed leaving the premises while holding a hot food bag and making his way to a vehicle. I was of the view that the male was in the process of making a delivery. Unaware of the licence conditions for the premises, Officers decided to confirm the hours for licensable activity before approaching the business.

Upon reviewing the licence for the premises, it was confirmed that the business is permitted to carry out licensable activity until 04:00, Monday to Sunday. I refer to the licence for Pizza 2 Night as **FO/1.** 

On the 25 February 2019, I visited the premises along with CER Officer Richard Lockett as a means of establishing whether the business is conducting licensable activity outside of their permitted hours. Officers met a member of staff by the name Ozil Safi who advised that there was no manager on site. Officers requested to view CCTV from the premises and was advised by the member of staff that he had only been working at the premises 30days and did not know how to operate the CCTV. The member of staff proceeded to call a manager who he advised is Alan Rasheed. After coming off the phone, the member of staff advised that the manager had requested that Officers returned at a later date to access CCTV.

It was noted that the business was in breach of their Annex 2 conditions which states under point 2 "A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorized council officer recent data or footage with the absolute minimum of delay when requested."

Officers informed the member of staff that under S179 of the Licensing Act 2003 that we would be crossing the counter in order to investigate further.

Upon checking on the Just Eat tablet for the business, Officers noted that the tablet was not able to generate order reports for previous days. While investigating Officers located a wad of receipts hidden discreetly behind menus.

I refer to **FO/2** which is a receipt generated on the 25 February 2019 at 04:26, detailing the provision of hot food outside of the permitted hours. Satisfied that the business is operating outside of the permitted hours, I requested the details for the manager to discuss my concerns. I was given the name Alan Rasheed and a contact number.

Upon returning to the office a voice message was left for Mr Alan Rasheed to make contact with the service to discuss my visit. Shortly after the voice message, at 16:39 an email was sent to members of the business management requesting CCTV footage for certain dates and times to assist in my investigation and to be provided within 48 hours as stipulated in within Annex of the business' licence;

"The premises shall install and maintain a comprehensive CCTV system. All entry

and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available upon the request of Police or authorized officer throughout the preceding 31 day period, such copies shall in any event be provided within forty-eight (48) hours." I refer to FO/3 which confirms this action.

As a result of no contact from the business, on 26 February 2019 at approx. 15:33 I returned to the premises with CER Officer Theo Bahannack to speak with a manager and deliver a letter containing the same information as my email. On this visit I again met Ozil Safi who was the only member of staff on the premise. Ozil advised that he had explained about my visit to his manager the day before and that he would be back by 6pm if I was willing to return. The letter which I refer to as FO/4 was then left with the member of staff.

At 23:56 on 26 February 2019, an email was sent from the manager for the business advising that there was playback error with their CCTV preventing them from making footage available to me. There was no indication of whether they would meet my deadline or if they would be able to obtain the requested footage and deliver it to the office. I refer to the email from the manager as FO/5.

As of the date of this application, the management have failed to provide the requested CCTV footage, this amounts to the following offence under the Licencing Act 2003;

\$179(4) offence - Rights of entry to investigate licensable activities; "A person commits an offence if he intentionally obstructs an authorised person [or an immigration officer] exercising a power conferred by this section."

#### History

Pizza 2 Night previously came to the attention of the Crime, Enforcement and Regulation Service following an unannounced compliance visit by Officers Clare Chown and Daniel Power on 11 November 2018. At the time of the visit, the premise was licensed for the provision of hot food up until 02:00, however at 03:20 Officers observed the premise continue to accept and process orders with no indication of stopping which amounted to a S136 offence. I refer to the copies of receipts obtained detailing the unlicensed activity as **FO/6**.

I refer to the compliance report by Daniel Power as FO/7. During this inspection the following breaches were also observed;

- S57(4) failure to secure a premises licence or a certified copy at the premises or to prominently display a summary of the Licence.
- S57(7) failure to produce a premises licence or a certified copy.

As a means of education, following this visit Officers invited the management to discuss the matter and apply for a variation to assist the business in operating in accordance with the Act. As part of this process the management requested a licence permitting them to sell hot food until 04:00, this was granted under good faith

that the business would operate responsibly. I refer to FO/8 which is an email from CER Officer Clare Chown detailing the breaches and how the business can apply for a variation.

It is deeply concerning that within 3 months of applying for a variation, there is evidence that the business is still unable to keep with the conditions of their licence and there is a clear disregard towards the licencing objectives.

Despite visits from the Crime, Enforcement and Regulation Service and requests for the CCTV to made, it appears that the management for the business do not acknowledge the severity of the situation or their responsibility to safeguard the licencing objectives

I am therefore of the view that enough education and guidance has been provided to the premises, leaving no alternative than for enforcement action to be taken.

#### Recommendations:

The Crime, Enforcement and Regulation Service considers the following measures appropriate as a means of ensuring the safeguarding of the key licensing objectives.

- Restricting the provision of hot food on Monday to Thursday till 01:00
- Restricting the provision of hot food on Friday to Sunday till 02:00
