LEWISHAM SAFER NEIGHBOURHOOD BOARD

Six "Community Board Member" positions available

LCPCG have ensured that there will be democratically elected places on the new Board – these will be known as the "Community Board Members" to distinguish them from the other positions, although most of those will also be filled from the local community.

There are 6 Community Board Member places available at this first election. They will have either a 1, 2, or 3 year length of term, depending on the voting.

We have written a role description for Board Members so applicants could know what is be expected of the position, and we will all be clear what their responsibilities are to the Board. Further information can also be found in the Draft Terms of Reference and Draft Code of Conduct for the Safer Neighbourhood Board.

Who can vote?

It is not LCPCG's own election and so there is a slightly different set of people who are entitled to vote. This set of people is known as the Register of Affiliated Groups for the Lewisham Safer Neighbourhood Board. All the founding names on this Register have transferred over from the LCPCG's own membership. The Register was closed temporarily on 18 Feb for 2 weeks, but it will be reopened after the election when anyone representing a local group will be able to join.

Every person whose name is on the Register is entitled to a vote. It is possible to send another person to vote on your behalf but advance notice must be sent from the person who is on the Register and it must arrives at least 24 hours before the start of the meeting.

Who are the candidates?

There are 11 candidates who would like your vote in this election. All 11 are on the Register and have been confirmed as eligible to stand.

I am presently a member of Lewisham CPCG Strategy Group and have been working on the transition from a Community Police Consultative Group to a Safer Neighbourhood Board with colleagues on the Group. This has included representation and participation on the London Policing Communities Partnership and the Mayors Office for Policing and Crime.

Chief Gilbert Oshevire

I am Chief Gilbert Oshevire. A retired Senior Nursing officer who offered professional nursing services in most of the NHS hospitals in London for more than 45 years before I retired honourably from active service. In 1973 I was a member of Race Relation Board in the London Borough of Lewisham resolving the problem of Race Inequality. Following this, I joined Lewisham Community Police Consultative Group. And I have for more than 15 years, an active member, helping police in dealing and reducing crime in our words of mouth in discussions and actions. One example of this is the project of gun and knife crime project that I headed successfully in year 2010, at Stephen Laurence Centre in Deptford, London SE8.

And I am proud to say, that since then, there has been a tremendous drop in incident of knife and gun crime in the Borough of Lewisham. And this free self-sacrifice service in our neighbourhoods continues.

Gordon Glean

Gordon Glean has worked for Lewisham Shopping for 20 years as the Centre's Security Manager. As part of the Shopping centres policy on Social & Corporate Responsibilities Gordon has worked with a number of local community groups such as: Race Equality Councils, Victim Support, Independent Advisory Group, Schools and CPCG for over 18 years. He has assisted in dealing with a broad selection of issues in Lewisham working closely with the Lewisham police senior management team, advising on community concerns.

Considered by the Metropolitan Police Authority and the Metropolitan Police Service as being one of the best in London, Gordon stood down as Chair of the Stop & Search / Account Scrutiny group for the CPCG in Lewisham after 10 years in 2012. He was also involved in the central Stop & Search group in Scotland Yard and the MPA's Community Monitoring Network. Gordon was invited by the MPS to deliver a presentation on community/police engagement to all 32 borough commanders, as part of the MPS STOP IT initiative, reflecting the work of the Lewisham Stop & Search Scrutiny Group. He is currently involved in the central Trident IAG at Scotland Yard and caretaker Chairperson for the local IAG.

Jackie Addison

I am seeking election to the Lewisham Safer Neighbourhood Board because I believe I can bring the relevant and necessary skills and experience to help it succeed. As LCPCG Chair I made sure that the LCPCG was involved from the very beginning in the process around setting up the Lewisham Board. The LCPCG have expertise in Community Police Engagement and I saw that this was made central to the new board's aims.

It is hard to set up a voluntary organisation from scratch. The most successful organisations are those that are set up by people to fulfil a perceived and shared need.
