1. Summary

1.1 This covering report summarises the contents of the presentation to the Sustainable Development Select Committee on Waste & Recycling Service Options in Lewisham.

3. Background

- 3.1 The Council is currently reviewing the services that it provides for waste and recycling. Through the London Waste & Recycling Board's (LWARB) Efficiencies Programme, a consultant has been appointed to identify savings, by undertaking a review of the Council's waste management services. As part of this review we would like to get the views of the Sustainable Development Select Committee.
- 3.2 This presentation aims to provide background on the current and future plans for waste management in Lewisham, including looking at a list of shortlisted options on future service arrangements.
- 3.3 This item intends to gather feedback from the Committee to inform the development of the strategy prior to going to Mayor and Cabinet later.

4. Overview of Presentation

 - This section introduces the LWARB Efficiencies Review, including all services that have been looked at, but focusses in on the kerbside waste and recycling services and analyses in turn the options that have been shortlisted. This section will also talk through the variables, costs and sensitivity testing to be undertaken of the modelled options.

 - The final section talks through the next steps that will be undertaken in this review of waste management in Lewisham.

5 Conclusion

5.1 Waste management is a large service area that affects all Lewisham residents. Given the legislative and economic pressures that are facing the Council, waste services are currently being reviewed to be more efficient and effective, at the same time as identifying savings moving forward.
