1. Summary

- 1.1 This report informs Mayor and Cabinet of the comments and views of the Overview and Scrutiny Committee, arising from discussions held on Sustainability and Transformation Plans in London at its meeting on 22 January 2018.

2. Recommendation

- 2.1 Mayor and Cabinet is recommended to note the views of the Overview and Scrutiny Committee as set out in section three of this referral; receive the report on Sustainability and Transformation Plans in London produced by the King's Fund and the Nuffield Trust; and ask the Executive Director for Community Services and to provide a response.

3. Overview and Scrutiny Committee views

- 3.1 At the Committee's meeting on 22 January 2018, Councillors received a report from the Our Healthier South East London (OHSEL) Board and heard from the Lewisham Clinical Commissioning Group (CCG); the Save Lewisham Hospital Campaign; and the Executive Director for Community Services.
- 3.2 The Committee also considered a report on Sustainability and Transformation Plans in London produced by the King's Fund and the Nuffield Trust. (Appendix A). Following a detailed discussion, The Committee agreed to:
1. Refer the King's Fund / Nuffield Trust report to Mayor and Cabinet (Appendix A).
 2. Ask the Mayor and Cabinet to note that King's College Hospital NHS Foundation Trust did not submit an update to the Overview and Scrutiny Committee, as had been requested following the resignation of Lord Kerslake and the decision by NHS Improvement to place the trust into special measures.
 3. Ask the Mayor and Cabinet to conduct a risk analysis of the current situation at King's College Hospital NHS Foundation Trust in terms of the impact on the local health economy.
 4. Ask the Mayor and Cabinet to conduct a risk analysis of Accountable Care Systems and Accountable Care Organisations as the committee is concerned that these systems and bodies, and their implications, are not yet fully understood.

4. Financial Implications

- 4.1 There are no financial implications arising out of this report per se.

5. Legal Implications

- 5.1 The Constitution provides for Select Committees to make recommendations to the Executive or appropriate committee and/or Council arising from the outcome of the scrutiny process.

6. Further Implications
