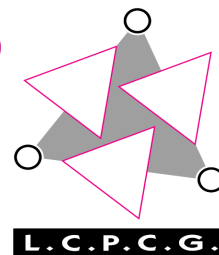

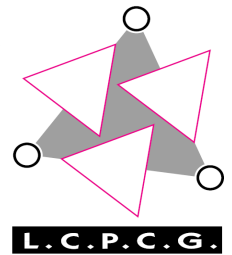

Code of Conduct for the Resident's Question Time Meeting

This meeting is open to the members of the LCPCG and the wider public:

- Only questions on community-wide issues related to the topic of policing or community safety should be raised - not political commentary or personal stories.
- Individual concerns and issues should be raised with the appropriate people either in advance of the meeting, before the meeting commences or after the meeting closes.
- Questions will be taken at the discretion of the Compère
- Questions will be selected from those written questions received in advance, and also spoken questions from those attending the meeting.

The audience are expected to engage in open, honest, fair and courteous discussion and debate;

- Only speak when called upon by the Compère;
- Actively listen, without interruption, to other speakers;
- Indicate to the Compère when they wish to speak;
- Keep comments brief and to the point;
- Respect the views of others attending and speaking at the meeting;
- Not use offensive language, for example by swearing or making racist, sexist or ageist remarks;
- Allow the Chair and Compère to direct the meeting, including bringing discussions to a close.

The LCPCG is an independent forum where communities can meet senior representatives of the police, local authority and other relevant organisations, to discuss and influence local policing and other aspects of community safety. Members include a wide range of community groups and organisations, including tenants associations, churches, Safer Neighbourhood ward panels, youth groups, and local business representatives.
