Recommendation

To consider the decision made by the Mayor Cabinet on 21 October 2003 which will come in to force on 4 November 2003 unless the Panel objects and calls it in.

On 21 October 2003 the Mayor and Cabinet made the following decisions:

1. <u>Crofton Secondary School - Determination of Proposal to Increase the</u>
Admission Number

1.1 Summary

- 1.1.1 On 2 April 2003, the Mayor agreed that a Public Notice should be issued for the expansion of Crofton School from 6 forms of entry to 8 forms of entry (fe).
- 1.2 This report set out the outcome of the Public Notice, which is that no objections were received, and recommended that the Mayor determine to proceed with the proposals to expand Crofton School from 6fe to 8fe.
- 2. The Mayor agreed that:
 - (i) in accordance with the powers set out in Schedule 6 to the School Standards and Framework Act 1998, the Authority does determine to implement the proposals for Crofton Secondary School, as set out in the Public Notice issued on 7 May 2003 and attached as an appendix to the report; and
 - (ii) in accordance with the powers set out in Schedule 6 to the School Standards and Framework Act 1998, the School Organisation Committee for Lewisham be informed of the decision to determine

the proposals.
