#### **Recommendation**

To consider the decision made by the Mayor and Cabinet on 25 February 2004 which will come in to force on 9 March 2004 unless the Panel objects and calls in any of them.

The Mayor and Cabinet on 25 February made the following decision:-

#### 1. A Compact between the Council and the Department for Education and Skills

#### 1.1 Summary

- 1.1.1 By 31 March 2004, each authority has been encouraged to agree with the Government's DfES the overarching priorities for the subsequent year. The current exercise is the first in what will become an annual cycle. This paper outlined the rationale for such a Compact and provides a draft for approval.
- 1.1.2 Whilst not statutory, guidance makes clear that it is the Secretary of State's expectation that each and every authority will undertake a review of its developmental priorities between September 2003 and now and discuss the outcome with one of his key officers, notably the Schools Directorate Adviser (SDA) at a formative stage. Guidance further indicates that schools and the broader educational community should be consulted. It is acknowledged that, particularly in the first instance, there will be a close similarity between those priorities established as part of the Education Development Plan (EDP) and those in its Compact; hence, there is some discretion left to authorities as to how they manage the consultation exercise. Lewisham has elected to involve all schools in the formulation of its first Compact and this paper presented a draft of that document for approval. It is worth noting that further changes are the subject of current proposals, to replace the current planning regime with a Single Education Plan (SEP) for April 2005. However, even after implementation of SEPs, Compacts will continue.

1.2 The Executive Director for Education and Culture amended the recommendation set out in the report to read as follows:-

The Mayor is recommended to approve the draft Compact and agree that the finalising of the Compact be delegated to the Executive Director for Education and Culture before submission to the Secretary of State for signature .

1.3 The Mayor and Cabinet approved the draft compact and agreed that the finalising of the compact be delegated to the Executive Director for Education and Culture, in consultation with the Cabinet Member for Children and Young People, before submission to the Secretary of State for signature.
