This practice requires the unanimous consent of this committee

- (g) Overview and Scrutiny Business Panel

NOTE: In accordance with Article 6 of the Constitution, this will consist of the Chair and Vice Chair of the Overview and Scrutiny Committee, the Chair of each of the select committees appointed by the Overview and Scrutiny Committee and 3 or the smallest number higher of Councillors required to ensure the political composition of the Council is reflected.

(h) Overview & Scrutiny (Education) Business Panel

NOTE: In accordance with Article 6 of the Constitution, this will consist of those members of the Council appointed to the Business Panel plus 2 Diocesan Representatives and 3 Parent Governor representatives.
