## 6. Term Time Only

The purpose of this report is to provide Schools Forum with an update regarding the Term Time Only settlement and to define the timelines for the next steps.

Mala Dadlani – Strategic Business Partner and Diane Parkhouse – HR Manager provided an update and information on TTO. This included confirmation of the TTO agreement with Trade Unions and next steps to settle payment. Officers noted that the process has been more complicated than originally anticipated, however officers were working hard to support as the process. Expectation is that most payments (subject to individuals agreeing their claims details) should be paid in this financial year. Leavers have till 28<sup>th</sup> February to log a claim. Leaver's claims will be assessed individually and most likely to be paid in the next financial year.

Mala will review funding strategy and update schools with potential final position for February/March reimbursements.

Further engagement is required with schools off Lewisham payroll and academy schools.

The report also proposed a method of supporting those schools in extreme financial challenging situations. Method proposed in report has been agreed. Activity on this will take place in 2022/23 post closure of accounts as one key criteria is that the school should be in a deficit. Chair and vice chair will be briefed on the schools in receipt of funding to support accountability and transparency. Schools Forum will receive a high level report. Any unallocated funding will be referred back to schools forum.

# 7. Dedicated Schools Grant 2020/21 Outturn (update on Early Years) & 2021/22 Provisional Outturn

Mala Dadlani – Strategic Business Partner provided an update on DSG 2020/21 outturn which recognised that for 2020/21 £1.251m was not clawed back for early years. This is an improved position than previously expected (redefined for covid). School Forum has agreed in line with table - net balance of circa £721k to be redistributed amongst all providers. The fairest view would be to consider the total number of hours (pupils) supported by each provider in autumn 2020 and allocate this funding as a one off reimbursement. At present this work has not been done as the announcement was only made last week.

# DSG grant outturn and 2021/22 provisional outturn

Central Schools Services Block is expected to be on target for this year largely as some costs are supported from alternative funding streams as one off funding.

Schools block is expected to be on target as previously noted with schools forum.

The expectation continues to be that the High Needs Block will overspend by between £5m to £6m. This would therefore result in a cumulative overspend position of circa £9m.

The number of EHCPs continues to cause a pressure with disproportionate numbers now being placed out of borough. This also places pressure on the general fund as transport is a general fund cost.

The Early Years Block remains provisional.

# 8. 2022/23 Dedicated Schools Grant Mandate

Main focus is for Schools Forum to consider and agree the main components of the funding formula that will enable Lewisham Council to provide a draft funding formula (known as the APT tool), to the Department for Education (DfE), in January. This report was presented to Forum for information only.

School Forum has agreed in line with the reports on Alignment to the National Funding Formula, De-Delegation, Minimum Funding Guarantee (MFG) uplift and Schools Contingency.

School Forum has requested an additional report on Lewisham Learning to further consider request for additional de-delegation arising from the anticipated reduction in the school improvement and brokerage grant.

#### 9. Any Other Business

Noted the release of the Schools forum papers for the 20th January 2022 meeting will have a reduced dispatch period of potentially 3 days.
