Annex 1- Mandatory conditions

No supply of alcohol may be made at a time when no designated supervisor has been specified in the licence or at a time when the designated premises supervisor does not hold a personal licence or his or her licence has been suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

All embedded conditions inherent with the Licensing Act 1964.

Annex 2-Conditions consistent with the operating Schedule

If a disc jockey is used on the night then he/she will ask customers to leave quietly.

Free drinking water will be available at all times.

Additional patrols will take place by members of staff, internally and externally, to limit any noise pollution when entertainment is being offered within the premises.

When children are allowed upon the premises, any entertainment offered within the premises will be suitable for young persons.

Children will be required to be supervised by the accompanying adult at all times.

A recognised Proof of Age policy will be enforced.
